Following the Korean government's plan for comprehensive trade automation, KTNET started paperless business in 1989 with 100\% investment by the Korea International Trade Association (KITA), and also designated as a trade automation business (presently known as National Paperless Trade Infrastructure Provider) in 1992 by the Korean government.

Through the world's foremost trade system connecting over 105,000 customers such as trade-related organizations, import and export companies, banks, customs brokers,
 shipping companies, insurance firms, freight forwarders, and bonded warehouses, KTNET processed over 390 million transactions with 875 types of digitalized export \& import documents in the G2B as well as B2B sectors in 2019.
